STIPULATION AND AGREED ORDER EXTENDING THE CLAIMS OBJECTION DEADLINE FOR PROOF OF CLAIM NOS. 546, 547, AND 564.

The Liquidating Trustee² and the Department of Treasury – Internal Revenue Service (collectively, the "Parties") hereby enter into this stipulation and agreed order (the "Stipulation and Order") as follows:

WHEREAS, on December 6, 2021, Strike, LLC ("Strike") and certain of its affiliates, including Crossfire, LLC ("Crossfire"), filed voluntary petitions under Chapter 11 of the Bankruptcy Code, commencing Bankruptcy Case No. 21-90054 in the Southern District of Texas (the "Bankruptcy Case");

WHEREAS, on May 17, 2022, the Court entered its Order (I) Approving the Disclosure Statement, (II) Confirming the Debtors' Joint Chapter 11 Plan of Liquidation, and (III) Granting Related Relief [Docket No. 1111] (the "Confirmation Order") confirming the Second Modified Combined Disclosure Statement and Joint Chapter 11 Plan of Liquidation of Strike, LLC and Its Affiliated Debtors [Docket No. 1094] (the "Plan"). The Effective Date of the Plan occurred on

The Debtors in these chapter 11 cases, along with the last four digits of each Debtors' federal tax identification number, are: Strike, LLC (2120); Strike HoldCo, LLC (0607); Delta Directional Drilling, LLC (9896); Strike Global Holdings, LLC (4661); Capstone Infrastructure Services, LLC (0161); and Crossfire, LLC (7582). June 6, 2022. After the Effective Date, the Liquidating Trustee has the power to object to and settle Disputed Claims. Plan Art. VIII.D.4;

WHEREAS, the Plan Provides that the Court may extend the Claims Objections Deadline. Plan Art. XI.B.

WHEREAS, on February 11, 2022, the Department of Treasury – Internal Revenue Service (the "IRS") filed Proof of Claim No. 425³, asserting an initial priority tax claim in the amount of \$799,537.97 and an initial general unsecured claim in the amount of \$166,943.00 ("Claim 425").

WHEREAS, on February 24, 2022, the IRS filed Proof of Claim No. 444⁴, asserting an initial priority tax claim in the amount of \$1,279,556.94 and an initial general unsecured claim in the amount of \$257,371.50 ("Claim 444").

WHEREAS, on October 31, 2022, the IRS filed Proof of Claim No. 546⁵, amending Claim 425 and asserting a secured claim in the amount of \$80,861.15, a priority tax claim in the amount of \$475,761.27 and a general unsecured claim in the amount of \$55,848.26 ("Claim 546").

WHEREAS, on November 2, 2022, the IRS filed Proof of Claim No. 5476, amending Claim 425 and asserting a secured claim in the amount of \$80,861.15, a priority tax claim in the amount of \$464,490.27 and a general unsecured claim in the amount of \$66,919.26 ("Claim 547").

WHEREAS, on November 6, 2024, the IRS filed Proof of Claim No. 5647, amending

Claim 444 and asserting a priority tax claim in the amount of \$813,330.30 and a general unsecured claim in the amount of \$500.00 ("Claim 564"). Collectively, Claim 546, Claim 547, and Claim 564 are referred to as the "IRS Claims."

WHEREAS, the Claims Objection Deadline for the IRS Claims is currently set for April 30, 2025.

WHEREAS, the Parties have engaged in discussions regarding resolution of their disputes, and seek to extend the Claims Objection Deadline for the Claim to June 13, 2025 to continue their discussions by this Stipulation and Order.

IT IS THEREFORE STIPULATED BY THE PARTIES AND HEREBY ORDERED THAT:

- The foregoing recitals are hereby incorporated by reference in this Stipulation and Order.
- The Claims Objection Deadline with respect to the IRS Claims is extended through
 June 13, 2025.
- 3. This Stipulation and Order is intended by each of the Parties to be binding upon their successors, agents, and assigns.
- 4. The undersigned hereby represent and warrant that they have full authority to execute this Stipulation and Order on behalf of their respective Parties.
- 5. The Stipulation and Order shall not be modified, altered, amended, or vacated without Bankruptcy Court approval.
- 6. The Bankruptcy Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Stipulation and Order, and the Parties hereby consent to such jurisdiction to resolve any disputes or controversies arising from or related to this Stipulation and Order.

7. Notwithstanding the applicability of Rule 6004(h) of the Federal Rules of Bankruptcy Procedure, the terms and conditions of this Stipulation and Order shall be immediately effective and enforceable upon entry of an Order approving the Stipulation and Order by the Bankruptcy Court.
