**FIFTH SUPPLEMENTAL DECLARATION OF PHILIP C. DUBLIN IN
SUPPORT OF THE APPLICATION OF THE OFFICIAL COMMITTEE OF
UNSECURED CREDITORS OF YELLOW CORPORATION, *ET AL.* TO
RETAIN AND EMPLOY AKIN GUMP STRAUSS HAUER & FELD LLP
AS LEAD CO-COUNSEL, NUNC PRO TUNC TO AUGUST 18, 2023**

Under 28 U.S.C. § 1746, I, Philip C. Dublin, declare as follows under the penalty of perjury:

1. I am an attorney admitted to practice in the State of New York and the United States District Court for the Eastern and Southern Districts of New York and have been admitted *pro hac vice* to the United States Bankruptcy Court for the District of Delaware for the purposes of these Chapter 11 Cases.² I am a member of the firm of Akin Gump Strauss Hauer & Feld LLP (“Akin”). Akin maintains offices at, among other places, One Bryant Park, New York, New York 10036. There are no disciplinary proceedings pending against me.

2. I am duly authorized to make this fifth supplemental declaration (the “Supplemental Declaration”) on behalf of Akin in support of the *Application of the Official Committee of Unsecured Creditors of Yellow Corporation, et al. to Retain and Employ Akin Gump Strauss*

Hauer & Feld LLP as Lead Co-Counsel, Nunc Pro Tunc to August 18, 2023 [Docket No. 597] (the “Application”).

3. Except as otherwise noted, all facts in this Supplemental Declaration are based on my personal knowledge of the matters set forth herein, information gathered from my review of relevant documents and information supplied to me by Akin.

4. On September 18, 2023, the Committee filed the Application, together with, among other things, the *Declaration of Philip C. Dublin in Support of the Application of the Official Committee of Unsecured Creditors of Yellow Corporation, et al. to Retain and Employ Akin Gump Strauss Hauer & Feld LLP as Lead Co-Counsel, Nunc Pro Tunc to August 18, 2023* (the “Original Declaration”), attached to the Application as Exhibit B and incorporated herein by reference.

5. On September 29, 2023, Akin filed the *Supplemental Declaration of Philip C. Dublin in Support of the Application of the Official Committee of Unsecured Creditors of Yellow Corporation, et al. to Retain and Employ Akin Gump Strauss Hauer & Feld LLP as Lead Co-Counsel, Nunc Pro Tunc to August 18, 2023* [Docket No. 690] (the “First Supplemental Declaration”). The Court entered an order approving the Application on October 4, 2023 [Docket No. 760].

6. On January 10, 2024, Akin filed the *Second Supplemental Declaration of Philip C. Dublin in Support of the Application of the Official Committee of Unsecured Creditors of Yellow Corporation, et al. to Retain and Employ Akin Gump Strauss Hauer & Feld LLP as Lead Co-Counsel, Nunc Pro Tunc to August 18, 2023* [Docket No. 1979] (the “Second Supplemental Declaration”). On September 23, 2024, Akin filed the *Third Supplemental Declaration of Philip C. Dublin in Support of the Application of the Official Committee of Unsecured Creditors of Yellow Corporation, et al. to Retain and Employ Akin Gump Strauss Hauer & Feld LLP as Lead Co-*

Counsel, Nunc Pro Tunc to August 18, 2023 [Docket No. 4386] (the “Third Supplemental Declaration”). On December 13, 2024, Akin filed the *Fourth Supplemental Declaration of Philip C. Dublin in Support of the Application of the Official Committee of Unsecured Creditors of Yellow Corporation, et al. to Retain and Employ Akin Gump Strauss Hauer & Feld LLP as Lead Co-Counsel, Nunc Pro Tunc to August 18, 2023* [Docket No. 5167] (together with the Original Declaration, the First Supplemental Declaration, the Second Supplemental Declaration and the Third Supplemental Declaration, the “Prior Declarations”).

7. On January 15, 2025, counsel to the Debtors filed a supplemental declaration identifying additional potential parties in interest in these Chapter 11 Cases [Docket No. 5411] (the “Supplemental Debtor Declaration”).

8. In reviewing the Supplemental Debtor Declaration, Akin identified the names of those additional potential parties in interest that were not included on **Schedule 1** of any of the Prior Declarations. The names of these additional parties in interest, as well as other additional parties in interest identified by Akin, are set forth on **Schedule 1** attached hereto (the “Additional Searched Parties”).³

9. In preparing this Supplemental Declaration, Akin submitted the names of the Additional Searched Parties to its Conflicts Database and conducted a review of the Additional Searched Parties in accordance with the procedures described in the Original Declaration.

10. Set forth on **Schedule 2**, attached hereto, is a listing of the Additional Searched Parties from **Schedule 1** that Akin either (a) currently represents (or represents a related party thereto) (the “Current Clients”) in matters wholly unrelated to these Chapter 11 Cases or (b) has,

in the past three calendar years, represented (or represented a related party thereto) in matters wholly unrelated to these Chapter 11 Cases (the “Former Clients”).⁴

11. Set forth on Schedule 3, attached hereto, is a listing of those Additional Searched Parties that currently serve or have, in the past three calendar years, served on informal and/or official creditors’ committees represented by Akin in chapter 11 cases (other than these Chapter 11 Cases).

12. On April 7, 2025, Benjamin Sharp joined Akin as an associate in the corporate group in Akin’s Dallas office. Prior to joining Akin, Mr. Sharp worked at Kirkland & Ellis LLP, where he worked on matters representing Yellow Corporation and/or certain of its affiliated companies, both prior to the Petition Date and during these Chapter 11 Cases. I do not believe that Mr. Sharp’s work on such matters precludes Akin from meeting the disinterestedness standard under the Bankruptcy Code. Moreover, Akin has instituted formal screening measures to screen Mr. Sharp from all aspects of Akin’s representation of the Committee in these Chapter 11 Cases.

13. By reason of the foregoing and as set forth in the Prior Declarations, to the best of my knowledge and information, I continue to believe that Akin neither holds nor represents any interest adverse to the Committee, the Debtors or their creditors and, therefore, is capable of fulfilling its duties to the Committee and the unsecured creditors that the Committee represents.

Notwithstanding the foregoing, whether an actual client relationship exists can only be determined by reference to the documents governing Akin’s representation rather than its listing in the Conflicts Database. As such, for purposes of the disclosures set forth herein, some of the disclosures set forth herein and on Schedule 2 may be overinclusive.
