31, 2025 (the "Compensation Period") in the amount of \$125,000.00; (b) payment in the amount of \$100,000.0, which is equal to 80% of Ducera's unpaid fees earned during the Compensation Period; and (c) interim allowance and reimbursement of 100% of the actual and necessary expenses incurred by Ducera during the Compensation Period in connection with such services in the amount of \$71.13. In support of this Monthly Fee Application, Ducera respectfully represents as follows:

JURISDICTION AND VENUE

- 1. This Court has jurisdiction over this Application pursuant to 28 U.S.C. §1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b). Venue is proper in this District under 28 U.S.C. §§ 1408 and 1409.
- 2. The statutory predicates for the relief requested herein are sections 330 and 331 of the Bankruptcy Code, Bankruptcy Rule 2016, and Local Rule 2016-1.

BACKGROUND

- 3. On February 19, 2025, (the "<u>Petition Date</u>"), the Debtors each commenced with the Court a voluntary case under chapter 11 of the Bankruptcy Code. The Debtors are authorized to continue to operate their business and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. No trustee or examiner has been appointed in these chapter 11 cases.
- 4. The Debtors are operating their businesses and managing their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.
- 5. On February 20, 2025, the Court entered an order [Docket No. 46] authorizing joint administration of the Debtors' chapter 11 cases pursuant to Bankruptcy Rule 1015(b) and Bankruptcy Local Rule 1015-1.

- 6. On February 27, 2025, the Office of the United States Trustee for the District of Delaware (the "<u>U.S. Trustee</u>") appointed a Committee of Unsecured Creditors (the "<u>Committee</u>") [Docket No. 96]. No trustee or examiner has been appointed in the Chapter 11 Cases. On April 23, 2025, the U.S. Trustee filed an *Amended Notice of Appointment of Creditors' Committee* [Docket No. 445].
- 7. On April 1, 2025, the Committee filed an application to retain and employ Ducera as its investment banker [Docket No. 268] (the "Retention Application"), effective as of March 6, 2025, pursuant to the terms of that certain engagement letter between Ducera and the Committee, dated as of March 6, 2025 (the "Engagement Letter"). A copy of the Engagement Letter was appended to the Retention Order (as defined below) as Exhibit 1.
- 8. On April 18, 2025, the Committee filed a *Certification of Counsel* regarding the Retention Application to address certain informal comments from the U.S. Trustee [Docket No. 427].
- 9. On April 21, 2025, the Court entered the order approving the Retention Application [Docket No. 431] (the "Retention Order"). The Retention Order, among other things, approved the Engagement Letter, as modified by the Retention Order, pursuant to section 328(a) of the Bankruptcy Code, and authorized the Debtors to pay, reimburse and indemnify Ducera in accordance with the terms and conditions of, and at the times specified in, the Engagement Letter.

RELIEF REQUESTED

10. By this Monthly Fee Application, in accordance with the Interim Compensation Order, Ducera requests:

² Unless otherwise stated, all capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Engagement Letter.

- (a) interim allowance of compensation for professional services rendered on behalf of the Committee during the Compensation Period in the amount of \$125,000.00;
- (b) payment in the amount of \$100,000.00, which is equal to 80% of Ducera's unpaid fees earned during the Compensation Period; and
- incurred by Ducera during the Compensation Period in connection with such services in the amount of \$71.13.
- 11. Attached hereto as **Exhibit A** & **B** is a summary of time detail by task and a summary of time detail by professional Although Ducera, in line with market convention, does not bill by the hour, Ducera kept track of its post-petition time in half-hour increments in accordance with the Retention Order. Such time records are attached hereto as **Exhibit C**. During the Compensation Period, Ducera professionals spent approximately 273.5 hours providing investment banking services to the Committee.
- 12. The fees charged by Ducera have been billed in accordance with the Engagement Letter and the Retention Order and are comparable to those fees charged by Ducera for professional services rendered in connection with similar chapter 11 cases and non-bankruptcy matters. Ducera submits that such fees are reasonable based upon the customary compensation charged by similarly skilled practitioners in comparable bankruptcy cases and non-bankruptcy matters in the competitive national investment banking market.
- 13. There is no agreement or understanding between Ducera and any other person, other than members of the firm, for the sharing of compensation to be received for services rendered in these chapter 11 cases.

SUMMARY OF SERVICES RENDERED

14. During the Chapter 11 Cases, Ducera rendered services to the Committee as requested and as appropriate in furtherance of the interests of unsecured creditors. The following summary of services rendered during the First Interim and Final Compensation Period is not intended to be a detailed description of the work performed, as those day-to-day services and the time expended in performing such services are fully set forth in Ducera's time records attached to the Monthly Fee Statements and/or this Application.
