DEBTORS' MOTION REQUESTING SECOND EXTENSION OF TIME TO FILE MONTHLY OPERATING REPORTS FOR APRIL 2025

TO THE HONORABLE COURT:

COME NOW, Debtors, through their undersigned attorneys, who respectfully state and pray as follows:

- 1. On August 15, 2023, Debtors filed their bankruptcy petitions under the provisions of Chapter 11 of the U.S. Bankruptcy Code (hereinafter the "Code"). (Docket entry No. 1, in each captioned case)
- 2. The Monthly Operating Reports (MOR) correspond to the month of March 2025 were filed. (Docket no. 1345)¹ But in other eight cases, like General Contracting Services Inc. (Case no. 23-02517 ESL) the MOR corresponding of April 2025 was filed on June 11, 2025.
- 3. Debtors continue working with their internal accounting staff and the firm of Luis Carrasquillo, CPA, in the preparation of the MOR to be filed in these cases corresponding to the month of April 2025.
- 4. On May 21, 2025, Debtors filed a motion requesting a previous extension of time of

twenty-one (21) days to file the Monthly Operating Report for April 2025, which was granted by

this Honorable Court on May 22, 2025. (Dockets No. 1348 & 1350)

5. Notwithstanding all efforts undertaken regarding the Monthly Operating Report for this

corresponding month, Debtors will not be able to file the same on June 11, 2025, given the

circumstances explained above.

6. In simple terms, the preparation of the MORs for the month of April 2025 has taken more

time than previously expected by the Debtors.

7. Therefore, Debtors believe that in order to complete and file the Monthly Operating Report

for the month of April 2025, they will need a second extension of time of twenty-one (21) days,

due on July 2, 2025.

WHEREFORE, Debtors pray this Honorable Court to take notice of this matter and to

allow them to file the corresponding Monthly Operating Reports of April 2025, on or before July

2, 2025.
