ORDER AUTHORIZING REJECTION OF THE ZOOM CONTRACT

Upon the motion (the “Motion”)² of the above-captioned debtors and debtors in possession (the “Debtors”) for entry of an order authorizing them to reject the contracts listed on **Schedule 1** annexed hereto as of the Rejection Date (as defined below); and this Court jurisdiction to decide the Motion and to enter this Order pursuant to 28 U.S.C. § 1334; and consideration of the Motion being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper in the Court pursuant to 28 U.S.C. § 1408; and due and proper notice of the Motion having been provided, such notice being proper under Bankruptcy Rule 6006(c) and adequate and appropriate under the circumstances; and the form satisfying the requirements of Bankruptcy Rule 6006(f); and this Court having found that the notice of the Motion and of the opportunity to be heard at the hearing thereon were appropriate under the circumstances and that no other notice need be provided, except as set forth herein; and this Court having reviewed the Motion and having heard the statements and argument in support of the relief requested at a hearing before this Court (the “Hearing”); and

this Court having determined that the legal and factual bases set forth in the Motion and at the Hearing establish just cause for the relief granted herein; and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefor, it is **HEREBY ORDERED THAT:**

1. The contracts listed on **Schedule 1** attached hereto are hereby rejected as of September 3, 2025 (the "Rejection Date").

2. Any claims based on the contracts set forth on **Schedule 1** shall be filed in accordance with any order of this Court establishing the applicable bar date for filing a proof of claim. The Debtors reserve the right to object to any claim based on the contracts set forth on **Schedule 1** at any time prior to or on the Effective Date or such deadline as may be set in the Debtors' plan of reorganization.

3. Nothing herein shall prejudice the rights of the Debtors to argue that any of the contracts were terminated prior to the Rejection Date; that any claim for damages arising from the rejection of any contract is limited to the remedies available under the termination provision of such contract; or that any such claim is an obligation of a third party and not that of the Debtors or their estates.

4. Nothing in the Motion or this Order shall be deemed or construed as an approval of an assumption of any lease, sublease, or contract pursuant to Section 365 of the Bankruptcy Code.

5. Notwithstanding the relief granted in this Order and any actions taken pursuant to such relief, nothing in this Order shall be deemed: (i) an admission as to the amount of, basis for, or validity of any claim against the Debtors; (ii) a waiver of the Debtors' or any other party's right to dispute any claim; (iii) a promise or requirement to pay any particular claim; (iv) an admission that any particular claim is of a type described in the Motion; (v) a request or authorization to

assume, or adopt any agreement, contract, or lease pursuant to section 365 of the Bankruptcy Code; (vi) an admission as to the validity, priority, enforceability, or perfection of any lien on, security interest in, or other encumbrance on property of the Debtors' estates; or (vii) a waiver of any claims or causes of action which may exist against any entity under the Bankruptcy Code or any other applicable law.

6. Notwithstanding the relief granted in this Order, any payment made or to be made by the Debtors pursuant to the authority granted herein shall be subject to and in compliance with any interim and final orders, as applicable, authorizing the Debtors' use of cash collateral (such orders, the "Cash Collateral Order"), including compliance with any budget or cash flow forecast in connection therewith and any other terms and conditions thereof. Nothing herein is intended to modify, alter, or waive, in any way, any terms, provisions, requirements, or restrictions of the Cash Collateral Order.

7. To the extent there is any inconsistency between the terms of the Cash Collateral Order and the terms of this Order or any action taken or proposed to be taken hereunder, the terms of the Cash Collateral Order shall control.


8. Notice of the Motion as described therein is deemed good and sufficient notice the Motion and the relief requested therein.

9. Notwithstanding Bankruptcy Rule 6004(h), this Order shall be effective and enforceable immediately upon its entry.

10. The Debtors are authorized to take all actions that are necessary and appropriate to effectuate the relief granted in this Order.

11. This Court retains jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
