**STIPULATION AND AGREED ORDER REGARDING FORD MOTOR CREDIT  
COMPANY LLC’S MOTION FOR RELIEF FROM THE AUTOMATIC STAY**

[Related to Docket No. 1550]

Corelle Brands Acquisition Holdings LLC (f/k/a Instant Brands Acquisition Holdings Inc.) and its debtor affiliates (collectively, the “**Debtors**” or “**Reorganized Debtors**”, as applicable) and Ford Motor Credit Company, LLC (“**Ford**” and together with the Reorganized Debtors, the “**Parties**”), hereby enter into this stipulation and agreed order (this “**Stipulation**”) as follows:

**WHEREAS**, on June 12, 2023, the Debtors filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code (the “**Bankruptcy Code**”) in the United States Bankruptcy Court for the Southern District of Texas (the “**Court**”) thereby initiating the above-captioned chapter 11 cases (the “**Chapter 11 Cases**”), which are jointly administered for procedural purposes only pursuant to the Court’s *Order Directing Joint Administration of Chapter 11 Cases* [Docket No. 40];

**WHEREAS**, on February 22, 2024, the Court held a hearing to consider final approval of the *Combined Disclosure Statement and Joint Chapter 11 Plan of Reorganization of Instant Brands Acquisition Holdings Inc. and its Debtor Affiliates* (the “**Plan**”);

**WHEREAS**, on February 23, 2024, the Court issued its *Findings of Fact, Conclusions of Law, and Order (I) Confirming the Joint Chapter 11 Plan of Reorganization of Instant Brands Acquisition Holdings Inc. and its Debtor Affiliates and (II) Approving the Disclosure Statement on a Final Basis* [Docket No. 1146] (the “**Confirmation Order**”);

**WHEREAS**, the Plan became effective on February 27, 2024 (the “**Effective Date**”);

**WHEREAS**, pursuant to paragraph 24 of the Confirmation Order and Article XI.C of the Plan, the automatic stay under section 362 of the Bankruptcy Code terminated on the Effective Date;

**WHEREAS**, on October 13, 2025, Ford filed its *Motion for Relief from the Stay [and Co-Debtor Stay, if Applicable] Regarding 2020 Ford F250 Super Duty Regular Cab XL 4WD 6.2L V8, VIN 1506* [Docket No. 1550] (the “**Motion**”);

**WHEREAS**, the Motion was self-calendared for a preliminary hearing on November 6, 2025 at 9:00 A.M. (prevailing Central Time) in accordance with the local procedures for motions for relief from the automatic stay;

**WHEREAS**, counsel for the Parties have engaged in discussions for potential resolution of the Motion and exchanged information to identify discrepancies in the Parties’ respective payment records; and

**WHEREAS**, the Parties are committed to continuing to resolve any payment discrepancies between the Parties’ records.

**NOW THEREFORE**, the Parties hereby stipulate and agree and, upon entry by the Court, it is **ORDERED** that:

1. The Motion is moot without prejudice to the Parties' rights including, without limitation, Ford's rights to seek further relief and the Reorganized Debtors' rights to oppose or otherwise defend against such requested relief.


2. This Stipulation and Agreed Order may not be modified, amended, or vacated other than by a signed writing executed by the Parties and approved by the Court.

3. This Stipulation and Agreed Order is and shall be binding on the Parties and their successors and assigns.

4. This Stipulation and Agreed Order shall be effective immediately upon entry by the Court.

5. The Court retains exclusive jurisdiction with respect to all matters or disputes arising from or relating to the implementation, interpretation, and enforcement of this Stipulation and Agreed Order.
