**Clarification for the Record – Corporate Standing of Melissa Holding LLC**

For the record, and to maintain accuracy within the estate proceedings of **Advantage Holdco Inc. (Case No. 20-11259 JTD)**, it is hereby clarified that **Melissa Holding LLC** has **never held any equity interest** in Advantage Holdco Inc.

Melissa Holding LLC was established in Delaware in 1999 as a **structural and fiduciary entity** operating in parallel with **Primary Colors Leasing LLC**. Its purpose has been **technical, fiscal, and custodial**, focusing on the preservation of tax attributes, operational continuity, and administrative coordination within the estate.

Accordingly, Melissa Holding LLC is **not subject** to the extinguishment provisions of **Plan VII.A.15.b**, which apply exclusively to equity ownership. This clarification is submitted for **institutional recordkeeping** and to maintain transparency under court supervision.
