**NOTICE OF ADJOURNMENT OF CERTAIN DATES

PLEASE TAKE NOTICE that on October 20, 2025, the Honorable Christopher M. López, United States Bankruptcy Judge in the United States Bankruptcy Court for the Southern District of Texas (the “Court”) entered the *Order (I) Approving the Adequacy of the Disclosure Statement, (II) Approving the Solicitation Procedures with Respect to Confirmation of the Debtors’ Proposed Second Amended Joint Chapter 11 Plan, (III) Approving the Form of Ballots and Notices in Connection Therewith, (IV) Scheduling Certain Dates with Respect Thereto, and (V) Granting Related Relief* [Docket No. 999] (the “Disclosure Statement Order”),² which approved the *Disclosure Statement for the Second Amended Joint Chapter 11 Plan of Reorganization of Ascend Performance Materials Holdings Inc. and Its Debtor Affiliates* (the “Disclosure Statement”) with respect to the *Second Amended Joint Chapter 11 Plan of Reorganization of Ascend Performance Materials Holdings Inc. and Its Debtor Affiliates* (as may be amended, modified, or supplemented

from time to time, the “Plan”) and approving the Solicitation Packages (as defined in the Disclosure Statement Order) and procedures for soliciting votes on the Plan.

PLEASE TAKE FURTHER NOTICE that the Disclosure Statement Order established, among other things, (a) November 24, 2025, at 3:00 p.m. (prevailing Central Time) as the date for the hearing at which the Court will consider confirmation of the Plan, and (b) certain other dates and deadlines with respect to the confirmation process (the “Confirmation Timeline”).

PLEASE TAKE FURTHER NOTICE THAT, pursuant to paragraph 4 of the Disclosure Statement Order, the Debtors may modify the Confirmation Timeline as necessary with respect to the solicitation of votes to accept or reject the Plan, voting on the Plan, filing objections to confirmation of the Plan, and confirming the Plan.

PLEASE TAKE FURTHER NOTICE that the Debtors filed the *Notice of Adjournment of Confirmation Hearing and Related Dates and Deadlines* [Docket No. 1068] and the *Notice of Adjournment of Confirmation Hearing to December 9, 2025, at 1:00 P.M. (Prevailing Central Time) and Related Dates and Deadlines* [Docket No. 1070], adjourning the Confirmation Hearing to December 9, 2025, at 1:00 p.m. (prevailing Central Time).

PLEASE TAKE FURTHER NOTICE that certain dates and deadlines related to the Confirmation Timeline have been extended as follows:

The meeting code is “JudgeLopez.” Click the settings icon in the upper right corner and enter your name under the personal information setting. Hearing appearances must be made electronically in advance of both electronic and in-person hearings. To make your appearance, click the “electronic appearance” link on Judge López’s home page. Select the case name, complete the required fields and click “submit” to complete your appearance.
