





**ORDER (I) EXTENDING THE AUTOMATIC STAY TO THE  
NON-DEBTOR DEFENDANTS AND (II) GRANTING RELATED RELIEF**

Upon the motion (the “Motion”)<sup>2</sup> of the Debtors for entry of an order (this “Order”),  
authorizing, but not directing, the Debtors to (a) extending the automatic stay to (i) the Debtors’

employees, officers, and directors, (ii) certain independent physicians affiliated with the Debtors, and (iii) indemnity contract counterparties (collectively, the “Non-Debtor Defendants”) in the Lawsuits and Settlements, including those listed on **Schedule 1** attached hereto, and (b) granting related relief, all as more fully set forth in the Motion; and upon consideration of the First Day Declaration; and upon consideration of the objections to the Motion filed at Docket Nos. 914, 1004, 1005, 1006, 1007, 1029, 1036, 1042, 1044, 1055, 1066, 1069, 1071, and 1127; and the Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334 and the *Order of Reference of Bankruptcy Cases and Proceedings Nunc Pro Tunc* dated August 3, 1984, entered by the United States District Court for the Northern District of Texas; and the matter being a core proceeding within the meaning of 28 U.S.C. § 157(b)(2); and venue of this proceeding and the Motion in this District being proper pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court being able to issue a final order consistent with Article III of the United States Constitution; and due and sufficient notice of the Motion having been given under the particular circumstances; and the Court having reviewed the Motion and having heard the statements in support of the relief requested therein at a hearing before this Court (the “Hearing”); and the Court having determined that the legal and factual bases set forth in the Motion and at the Hearing establish just cause for the relief granted herein; and it appearing that no other or further notice is necessary; and it appearing that the relief requested in the Motion is in the best interests of the Debtors, their estates, their creditors, and other parties in interest; and after due deliberation thereon; and good and sufficient cause appearing therefor; it is hereby

**ORDERED, ADJUDGED, AND DECREED that:**

1. The Motion is granted as set forth herein.

2. The automatic stay is hereby extended to prohibit the continuation of the Lawsuits, the execution or enforcement of the Settlements, and the commencement of new lawsuits against the Non-Debtor Defendants or their affiliates during the pendency of these Chapter 11 Cases and until the effective date of any chapter 11 plan proposed by the Debtors.

3. For the avoidance of doubt, “Non-Debtor Defendants” shall not include any of the Debtors’ equity holders or investors; *provided; however*, that nothing in this Order shall modify the automatic stay as to claims asserted against any of the Debtors’ equity holders or investors, or any Non-Debtor Defendant, on the basis of alter ego, veil piercing, or other theories of derivative liability, which are property of the estate and remain subject to the automatic stay pursuant to Bankruptcy Code section 362(a)(3).

4. The automatic stay is hereby extended to prohibit the severing of claims in the Lawsuits by the applicable Non-Bankruptcy Court that would allow claims against the Non-Debtor Defendants to proceed.

5. Notwithstanding any provision in this Order, with respect to the case listed as No. 194 in Schedule 1 attached to Exhibit A of the Motion, “Ronda Rigsby, in and through her Successor-In-Interest, Brian Rigsby and Brian Rigsby, an individual v. Brier Oak on Sunset; Reier Oak on Sunset, LLC dba Brier Oak on Sunset, Summit Care, LLC, Genesis Healthcare, Inc; Genesis Administrative Services LLC” is withdrawn from the Motion by the Debtors and shall not be subject to this Order.

6. Notwithstanding any provision in this Order, with respect to the case listed as No. 236 in Schedule 1 attached to Exhibit A of the Motion, “Target Building Construction, Inc. v 3430 Huntingdon Pike Pa Owner LLC” the relief sought in the Motion is continued for purposes of this hearing subject to being reset by the Debtors and shall not be subject to this Order.

7. Nothing in the Motion or this Order or the relief granted (including any actions taken or payments made by the Debtors pursuant thereto) shall be construed as (a) authority to assume or reject any executory contract or unexpired lease of real property, or as a request for the same; (b) an admission as to the validity, priority, or character of any claim or other asserted right or obligation, or a waiver or other limitation on the Debtors' ability to contest the same on any ground permitted by bankruptcy or applicable non-bankruptcy law; (c) a promise or requirement to pay any claim or other obligation; or (d) granting third-party-beneficiary status, bestowing any additional rights on any third party, or being otherwise enforceable by any third party.

8. Notice of the Motion as provided therein shall be deemed good and sufficient notice of such Motion and the requirements of Bankruptcy Rule 6004(a), the Local Rules, and the Complex Case Procedures are satisfied by such notice.

9. All time periods set forth in this Order shall be calculated in accordance with Bankruptcy Rule 9006(a).

10. The Debtors are authorized to take all actions necessary to implement the relief granted in this Order.

11. The Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, or enforcement of this Order.
