**Notice of Transfer**

We refer to the claim (the "Claim") which Lehman Brothers International (Europe) (in members' voluntary liquidation) (formerly in administration) ("LBIE") submitted in the captioned proceedings, as follows:

1. (Claim Ref. No. 200035) allowed as a class 4B senior affiliate guarantee claim in the amount of \$19,727,757.00
2. (Claim Ref. No. 62786) allowed as a class 05 senior third-part guarantee claim in the amount of \$9,028,327.78
3. (Claim Ref. No. 200011) allowed as a class 4B senior affiliate guarantee claim in the amount of \$1,008,000,000.00

We hereby notify you that, pursuant to the terms of an Asset Assignment Agreement, dated September 3, 2025, between Lehman Brothers Holdings Plc (in administration) ("LBH") and LBIE and the Additional Transfer Notice dated December 05, 2025 given to LBH by LBIE pursuant thereto, we have transferred the Claim to LBH.

We hereby request you to record the transfer of the Claims to Lehman Brothers Holdings Plc (in administration), Pricewaterhousecoopers Llp, 7 More London Riverside, London, SE1 2RT, United Kingdom, and to pay all subsequent dividends in respect of the Claim to LBH.

We hereby notify you that, following a Court hearing on 8 October 2025, the LBIE Administration has now concluded and LBIE entered members' voluntary liquidation on the same day, Alison Grant, remains the Insolvency Practitioner.

The joint liquidators of LBIE (the "Liquidators") have signed this notice of assignment as agents for and on behalf of LBIE and neither they, their firm, its members, partners, directors, officers, employees nor any of their respective agents, advisers or representatives shall incur any personal liability whatsoever in respect of, or in relation to, this notice of transfer. The exclusion of liability set out in this paragraph shall arise and continue notwithstanding the termination of the agency of the Liquidators and shall operate as a disclaimer of any claims in tort as well as under the laws of contract, and any claims otherwise at law or in equity. The Liquidators, their firm and its members, partners, directors, officers, employees and each of their respective agents, advisers and representatives shall be entitled to rely on this paragraph as if they were a party to this notice of assignment.
