**FIFTH MONTHLY FEE STATEMENT OF FTI CONSULTING, INC., FOR
ALLOWANCE OF COMPENSATION AND REIMBURSEMENT OF EXPENSES FOR

Pursuant to the *Order (i) Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Retained Professionals and (ii) Granting Related Relief*, entered on August 28, 2025 [Docket No. 688] (the “Administrative Order”), FTI Consulting, Inc. (“FTI” or the “Firm”), financial advisor for the Statutory Unsecured Claimholders’ Committee (the “Committee”) hereby submits this monthly statement of services rendered and expenses incurred in this case (the “Monthly Fee Statement”) for the period from December 1, 2025 through December 31, 2025 (the “Statement Period”), pursuant to which FTI seeks payment of: (i) \$667,572.00 (80% of \$834,465.00) as compensation for professional services rendered; and (ii) \$4,643.53 for reimbursement of expenses. On October 2, 2025, this Court entered the *Order Authorizing Retention of FTI Consulting, Inc. for the Statutory Unsecured Claimholders’ Committee* [Docket No. 1128] (the “Retention Order”), authorizing the Committee to retain and compensate FTI subject to allowance of such compensation and reimbursement by the Court.
