**ORDER ALLOWING INTERIM COMPENSATION
AND REIMBURSEMENT OF EXPENSES
(Docket No. 1374)**

The Court has considered the *AlixPartners, LLP's Combined (i) Third Interim Fee Application for the Period from November 1, 2025 through December 19, 2025 and (ii) Final Fee Application for the Period From May 8, 2025 through December 19, 2025 For Allowance of Compensation for Professional Services Rendered and Reimbursement of Expenses Incurred as Financial Advisor for the Official Committee of Unsecured Creditors (the "Application")*, filed by *AlixPartners, LLP* (the "Applicant"). The Court orders:

1. The Applicant is allowed compensation and reimbursement of expenses in the amount of \$5,378,855.19 for the Final Period as set forth in the Application.
