ORDER GRANTING THIRD OMNIBUS OBJECTION OF THE LIQUIDATING TRUSTEE TO CERTAIN NO LIABILITY CLAIMS [RELATED DOCKET NO. 751]

Upon the motion (the “**Motion**”)² of the Liquidating Trustee of the Hopedale Creditors’ Trust (the “Liquidating Trustee”) of Hopedale Mining, LLC and its related debtors in the above-captioned chapter 11 cases (collectively, the “Debtors”), for entry of an order (this “**Order**”)

disallowing and expunging the claims identified on **Schedules 1 and 3** hereto pursuant to section 502 of the Bankruptcy Code, Bankruptcy Rule 3007, and Local Rule 3007-1; and the Court having found that the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334 and the *General Order 30-7* from the United States Bankruptcy Court for the Southern District of Ohio, dated January 29, 2024; and the Court having found this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2), and this Court may enter a final order consistent with Article III of the United States Constitution; and the Court having found that venue of this proceeding and the Objection in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court having found the relief requested in the Objection is in the best interests of the Trust, the Debtors, their estates, and other parties in interest; and the Court having found that the Liquidating Trustee provided adequate and appropriate notice of the Objection under the circumstances and that no other or further notice is required; and the Court having determined that the legal and factual bases set forth in the Objection and the Greenblatt Declaration establish just cause for the relief granted herein; and any responses in opposition to the relief requested in the Objection having been withdrawn or overruled on the merits; and after due deliberation and good cause appearing therefore, it is HEREBY ORDERED THAT:

1. The Objection is granted as set forth herein.
2. Each claim identified on **Schedule 1** to this Order is hereby disallowed and expunged in its entirety because the Debtors' estates are not liable for such claims based on the supporting documentation attached to each claim and the Debtors' books and records and/or other orders of this Court.

3 Each claim identified on **Schedule 3** to this Order is hereby disallowed and expunged in its entirety as such claims are “Priming Taxes” which were assumed by purchasers of the Debtors’ assets and are no longer claims against the Debtors’ estates.

4. The Debtors’ claims and noticing agent, Epiq Corporate Restructuring, LLC, is directed to update the claims register to reflect the relief granted in this Order.

5. Except as provided in this Order, nothing in this Order will be deemed: (a) an admission or finding as to the validity of any proof of claim against the Liquidating Trustee; (b) a waiver of the right of the Liquidating Trustee to dispute any proof of claim filed against the Debtors’ estates on any grounds whatsoever at a later date; (c) a promise by or requirement on the Liquidating Trustee to pay any claim; (d) an implication or admission that any particular proof of claim is of a type specified or defined in this Order; or (e) a waiver of the rights of the Liquidating Trustee under the Bankruptcy Code or any other applicable law, including, but not limited to, claims, defenses, or causes of action pursuant to sections 544-550 of the Bankruptcy Code.

6. Each of the claims and the objections by the Liquidating Trustee to each of the claims, as addressed in the Objection and set forth on **Schedules 1 and 3** to this Order, constitute a separate contested matter as contemplated by Bankruptcy Rule 9014. This Order will be deemed a separate Order with respect to each claim. Any stay of this Order pending appeal by any claimant whose claim is subject to this Order shall only apply to the contested matter that involves such claimant and will not act to stay the applicability or finality of this Order with respect to the other contested matters identified in the Objection or this Order.

7. The Liquidating Trustee is authorized to take all actions necessary to effectuate the relief granted pursuant to this Order.

8. The Liquidating Trustee shall serve this Order in accordance with all applicable rules and shall file a certificate of service evidencing compliance with this requirement.

9. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry.

10. The Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Order.
