**STIPULATION AND AGREED ORDER RESOLVING THE DEBTORS’  
AMENDED LIMITED OBJECTION TO CERTAIN CUSTOMER CLAIMS AND  
MOTION FOR TEMPORARY ALLOWANCE OF SUCH CUSTOMER CLAIMS  
FOR VOTING PURPOSES ONLY PURSUANT TO BANKRUPTCY RULE 3018**

This stipulation and agreed order (the “**Stipulation**”) and is entered into by and between (a) the above captioned debtors and debtors in possession (collectively, the “**Debtors**”) and (b) Nathaniel Camp (the “**Claimant**”). The Debtors and the Claimant shall be referred to individually as a “**Party**” and collectively as the “**Parties**”). The Parties hereby stipulate and agree as follows:

**RECITALS**

A. On July 7, 2025 (the “**Petition Date**”), the Debtors filed voluntary petitions for relief under Chapter 11 of the Bankruptcy Code (collectively, the “**Chapter 11 Cases**”) in the United States Bankruptcy Court for the Southern District of Texas (the “**Court**”). The Debtors continue to operate their business and manage their property as debtors and debtors in possession pursuant to Sections 1107(a) and 1108 of the Bankruptcy Code.

B. On September 15, 2025, the Court entered the *Order (I) Setting Bar Dates for Filing Proofs of Claim, Including Requests for Payment Under Section 503(B)(9), (II) Establishing*

*Amended Schedules Bar Date and Rejection Damages Bar Date, (III) Approving the Form and Manner for Filing Proofs of Claim, Including Section 503(B)(9) Requests, (IV) Approving Notice of Bar Dates and (IV) Granting Related Relief* [Docket No. 488] (the “**Bar Date Order**”) setting certain deadlines with respect to filing proofs of claim against the Debtors.

C. On December 11, 2025, the Court entered the *Order (I) Conditionally Approving the Adequacy of the Disclosure Statement, (II) Approving the Solicitation and Notice Procedures, (III) Approving the Forms of Ballot and Notices in Connection Therewith, (IV) Approving Management Selection Procedures, (V) Approving the Combined Hearing Timeline, and (VI) Granting Related Relief* [Docket No. 1142] (the “**Solicitation Order**”).

D. On November 12, 2025, the Claimant filed the following proofs of claim against Debtor Linqto Liquidshares LLC (collectively, the “**Liquidshares Claims**”):

- POC 14761 in the amount of \$55,025.54;
- POC 14786 in the amount of \$50,084.82;
- POC 14788 in the amount of \$60,050.93;
- POC 14792 in the amount of \$35,002.58;
- POC 14797 in the amount of \$100,110.00;
- POC 14801 in the amount of \$36,855.54; and
- POC 14810 in the amount of \$51,400.94.<sup>2</sup>

E. On November 12, 2025, the Claimant filed the following proofs of claim against Debtor Linqto Liquidshares Manager LLC (collectively, the “**Liquidshares Manager Claims**”):

- POC 14760 in the amount of \$36,855.54;
- POC 14764 in the amount of \$55,025.54;

- POC 14787 in the amount of \$50,084.82;
- POC 14790 in the amount of \$60,050.93;
- POC 14794 in the amount of \$35,002.58;
- POC 14799 in the amount of \$100,110.00; and
- POC 14811 in the amount of \$51,400.94.<sup>3</sup>

F. On December 23, 2025, the Debtors filed the *Debtors' Amended (I) Limited Objection to Certain Customer Claims and (II) Motion for Temporary Allowance of Such Customer Claims for Voting Purposes Only Pursuant to Bankruptcy Rule 3018* [Docket No. 1202] (as further amended by Docket No. 1313, the “**Claim Objection**”), seeking to temporarily disallow certain customer claims, including the Liquidshares Claims and Liquidshares Manager Claims, in the asserted dollar amounts and to temporarily allow such claims, solely for voting purposes, against Linqto Liquidshares LLC in the applicable share amounts set forth on Exhibit A to the proposed order filed with the Claim Objection.

G. On January 22, 2026, the Claimant filed *Nathaniel Camp's Response and Joinder in Response to Debtor's Limited Objection to Certain Customer Claims* [Docket No. 1410] (the “**Response**”).

#### **STIPULATION AND AGREED ORDER**

**NOW, THEREFORE**, in consideration of the foregoing recitals, which are incorporated into this Stipulation, the Parties stipulate and agree as follows:

1. The Liquidshares Claims were temporarily allowed solely for voting purposes, and

the Claimant voted on the Debtors' chapter 11 plan in the share amounts reflected on Exhibit A to the proposed order filed with the Claim Objection.

2. The Debtors hereby withdraw the Claim Objection as it relates to the Liquidshares Claims, without prejudice to the Debtors' rights to object to such claims on any other basis.

3. Except as otherwise provided herein, nothing in this Stipulation, nor any actions taken pursuant hereto, shall be deemed to be an admission by either Party as to the amount of, basis for, or validity of any claim against the Debtors for distribution purposes.

4. The terms and conditions of this Stipulation shall be immediately effective upon the Court's entry of an order approving this Stipulation.

5. The undersigned represent and warrant that they have full authority to execute this Stipulation on behalf of the respective parties and that the respective parties have full knowledge of, and have consented to, this Stipulation.

6. This Stipulation may be executed in counterparts and/or by facsimile or other electronic signature, and each such counterpart together with the others shall constitute one and the same instrument. The Claimant warrants and represents that it owns all of the claims which are the subject of this Stipulation and has not assigned or in any way transferred or conveyed all or any portion of such claims and that the Claimant has the sole right and exclusive authority to execute this Stipulation and receive the sums specified or referenced in this Stipulation.



The Parties agree that the Court shall retain exclusive jurisdiction with respect to all matters arising from or related to this Stipulation, enforcement, or the implementation of this Stipulation, and the Parties consent to such jurisdiction to resolve any disputes or controversies arising from or related to this Stipulation.
