ORDER EXTENDING THE CLAIMS OBJECTION DEADLINE

Upon the motion (the “Motion”)² of the Reorganized Debtor for entry of an order (this “Order”) extending the Claims Objection Deadline through and including October 16, 2026, all as more fully set forth in the Motion; and this Court having jurisdiction over this matter pursuant to 28 U.S.C. § 1334 and the *Order of Reference to Bankruptcy Judges* from the United States District Court for the Southern District of Texas, entered May 24 2021; and this Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b); and this Court having found that it may enter a final order consistent with Article III of the United States Constitution; and this Court having found that venue of this proceeding and the Motion in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and this Court having found that the relief requested in the Motion is in the best interests of the Reorganized Debtor’s estates, its creditors, and other parties in interest;


1. The Claims Objection Deadline with respect to all Claims, including Administrative Claims and Claims filed by Trade Vendors, is hereby extended through and including October 16, 2026.

2. Nothing in this Order shall prejudice the Reorganized Debtor's right to seek further extension of the Claims Objection Deadline in accordance with the terms of the Plan and the Confirmation Order.

3. Notwithstanding any Bankruptcy Rule to the contrary, the terms and conditions of this Order are immediately effective and enforceable upon its entry.

4. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
