**NOTICE OF ADMINISTRATIVE CLAIM BAR DATE AND PROCEDURES FOR
FILING ADMINISTRATIVE CLAIMS AGAINST THE DEBTOR'S ESTATE**

PLEASE TAKE NOTICE THAT the above-captioned debtor, Flipcause, Inc. (the “Debtor”) filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code (the “Bankruptcy Code”) in the United States Bankruptcy Court for the District of Delaware (the “Court”) on December 19, 2025 (the “Petition Date”).

PLEASE TAKE FURTHER NOTICE THAT on January 22, 2026, the Court entered an *Order Approving the Appointment of Jeffrey T. Testa as Chapter 11 Trustee* [Docket No. 67] which approved the appointment of Jeffrey T. Testa as chapter 11 trustee for the Debtor (the “Chapter 11 Trustee”).

PLEASE TAKE FURTHER NOTICE THAT on April 6, 2026 the Chapter 11 Trustee filed the *Chapter 11 Trustee’s Motion for Entry of an Order (I) Approving the Settlement With Grand Avenue Investments LP; (II) Converting the Chapter 11 Case to a Case Under Chapter 7 of the Bankruptcy Code; (III) Approving Conversion Procedures; (IV) (A) Establishing an Administrative Claim Bar Date, (B) Approving the Form and Manner for Filing Administrative Claims, and (C) Approving Notice Thereof; and (V) Granting Related Relief* [Docket No. 182] (the “Motion”).²

PLEASE TAKE FURTHER NOTICE THAT on April 29, 2026, the Court entered an order approving the Motion [Docket No.212] (the “Conversion Order”) and establishing **June 3, 2026 at 4:00 p.m. Eastern Time** as the deadline (the “Administrative Bar Date”) by which parties holding Administrative Claims against the Debtor’s estate must file such claims.

Administrative Claim Form

Access to the Administrative Claim Form and Additional Information. Administrative Claims are to be filed using the Administrative Claim Form (the “Administrative Claim Form”), attached hereto as **Exhibit A**, and submitted to the Court.

Administrative Claim Bar Date

The Court has established **4:00 p.m. (ET) on June 3, 2026**, as the deadline for all persons and entities holding any right to payment constituting a cost or expense of administration of the Debtor’s chapter 11 case arising under Bankruptcy Code sections 503(b) (with the exception of (i) any claims arising under Bankruptcy Code section 503(b)(9), and (ii) claims of the Professionals) and 507(a)(2) against the Debtor’s estate (each an “Administrative Claim” and each holder of such Administrative Expense Claim, and each holder of such Administrative Claim, an “Administrative Claimant”) arising from the Petition Date through entry of the Conversion Order to assert such claims (the “Administrative Bar Date”).

Parties Required to File Proofs of Claim

1. Definition of Claim. Under Bankruptcy Code section 101(5) and as used herein, the word “claim” means: (i) a right to payment, whether or not such right is reduced to judgment, liquidated, unliquidated, fixed, contingent, matured, unmatured, disputed, undisputed, legal, equitable, secured or unsecured; or (ii) a right to an equitable remedy for breach of performance if such breach gives rise to a right to payment, whether or not such right to an equitable remedy is reduced to judgment, fixed, contingent, matured, unmatured, disputed, undisputed, secured or unsecured. An Administrative Expense Claim is a Claim of the kind described in Bankruptcy Code section 503(b)(1), (2), (3), (4), (5), (6), (7), and (8). Administrative Expense Claims are given priority status pursuant to Bankruptcy Code section 507(a)(2), which means that they are paid before general unsecured claims.

2. Parties Who Must File Administrative Expense Claims. Except as set forth herein, the Administrative Bar Date shall apply to all Persons and Entities who hold an Administrative Claim (other than claims for Professional Fees) arising from December 19, 2025 through entry of the Conversion Order (or April 29, 2026) (the “Administrative Claims Period”).

3. Parties Who Do Not Need to File Proofs of Claim. The following Persons or Entities whose claims otherwise would be subject to the Administrative Claim Bar Date need not file a claim:

- a) Any Person or Entity asserting a claim for Professional Fees; and
- b) any Person or Entity holding a Claim payable to the Court or the United States Trustee Program pursuant to 28 U.S.C. § 1930; including, for the avoidance of doubt, any Administrative Claims asserted by the U.S. Trustee for statutory fees required to be paid by the Debtor.

Instructions for Asserting Administrative Expense Claims

1. Contents of Administrative Claim Form. Each Administrative Claim Form, as applicable, must (i) be written in English; (ii) include a claim amount denominated in United States dollars; (iii) conform substantially with the Administrative Claim Form, as applicable; and (iv) be signed by the holder of the claim or by an authorized agent or legal representative of the holder of the claim.

2. Supporting Documentation. Each Administrative Claim Form must include supporting documentation in accordance with Bankruptcy Rules 3001(c) and 3001(d) (or, upon prior written consent of the chapter 7 Trustee, if such documentation is voluminous, include a summary of such documentation) or an explanation as to why such documentation is not available; provided, however, that, upon the request for additional documentation, any such creditor that received such request shall be required to transmit such written documentation no later than five (5) business days following the date of such request

3. Timely service. Each Administrative Claim Form, including supporting documentation, must be submitted in person, by courier service, overnight delivery, hand delivery, or United States mail the Clerk of the United States Bankruptcy Court for the District of Delaware either (a) electronically via the interface available on the Court's website located at: <https://www.deb.uscourts.gov/claims-information> or (b) via First Class Mail to: United States Bankruptcy Court, Attn: Claims, 824 Market Street, 3rd Floor Wilmington, DE 19801 so that it is actually received, **not postmarked**, on or before the Administrative Claim Bar Date

Consequences of Failing to Timely Assert Your Claim

PURSUANT TO THE CONVERSION ORDER, ANY PERSON OR ENTITY WHO IS REQUIRED, BUT FAILS, TO TIMELY FILE AN ADMINISTRATIVE CLAIM BY THE ADMINISTRATIVE BAR DATE SHALL BE FOREVER BARRED, ESTOPPED AND ENJOINED FROM ASSERTING SUCH CLAIM AGAINST THE DEBTOR'S ESTATE (OR FILING A CLAIM WITH RESPECT TO ANY SUCH ADMINISTRATIVE CLAIM), AND THE DEBTOR AND ITS PROPERTY SHALL BE FOREVER DISCHARGED FROM ANY AND ALL INDEBTEDNESS OR LIABILITY WITH RESPECT TO OR ARISING FROM SUCH CLAIM.

ADDITIONALLY, ANY PERSON OR ENTITY THAT IS REQUIRED, BUT FAILS, TO TIMELY FILE AN ADMINISTRATIVE CLAIM BY THE ADMINISTRATIVE BAR DATE SHALL BE PROHIBITED FROM PARTICIPATING IN ANY DISTRIBUTION ON ACCOUNT OF SUCH CLAIM, AND (B) RECEIVING FURTHER NOTICES REGARDING SUCH CLAIM. SUCH PERSON OR ENTITY SHALL NOT BE TREATED AS A CREDITOR WITH RESPECT TO SUCH CLAIM FOR ANY PURPOSE.

Reservation of Rights

Nothing contained in this notice is intended to or should be construed as a waiver of the Chapter 7 Trustee's or any successors' rights to dispute, or assert offsets or defenses against, any filed Administrative Claim as to the nature, amount, liability, classification, characterization or validity thereof.

NEITHER THE CHAPTER 7 TRUSTEE, NOR THE CLERK OF THE COURT IS AUTHORIZED TO PROVIDE YOU WITH LEGAL ADVICE.

Administrative Claimant

An Administrative Claimant is any person, corporation, or other entity to whom the Debtor owes a debt for an administrative claim.

Administrative Claim Form

A form telling the Bankruptcy Court how much the Debtor owes a creditor for administrative claims.

Offers to Purchase a Claim

Certain entities are in the business of purchasing claims for an amount less than the face value of the claims. One or more of these entities may contact the creditor and offer to purchase the claim. Some of the written communications from these entities may easily be confused with official court documentation or communications from the Debtor. These entities do not represent the bankruptcy court or the Debtor. The creditor has no obligation to sell its claim. However, if the creditor decides to sell its claim, any transfer of such claim is subject to FRBP 3001(e), any applicable provisions of the Bankruptcy Code (11 U.S.C. § 101 *et seq.*), and any applicable orders of the bankruptcy court.
