10 **ORDER GRANTING DEBTOR'S THIRD OMNIBUS OBJECTION TO**
11 **ADMINISTRATIVE CLAIMS – DUPLICATED CLAIMS**

12 **WHEREAS**, on August 15, 2023 (the “**Petition Date**”), Grupo HIMA San Pablo, Inc.,
13 together with its affiliated debtors (collectively, the “**Debtors**”), filed voluntary petitions for relief
14 under chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the District
15 of Puerto Rico (the “**Court**”), thereby commencing the above-captioned chapter 11 cases (the
16 “**Chapter 11 Cases**”) (Docket No. 1).¹

17 **WHEREAS**, on February 23, 2024, the Debtors filed a *Motion for Order (I) Fixing a*
18 *Deadline for Filing Requests for Allowance of Administrative Expense Claims and (II)*
19 *Designating Form and Manner of Notice Thereof* (Docket No. 724); and on March 19, 2024, the
20 Court entered an order establishing a deadline for filing administrative expense claims (the
21 “**Administrative Expense Bar Date**”) (Docket No. 775).

22 **WHEREAS**, on March 3, 2026, the Debtors filed their *Debtors’ Third Omnibus Objection*
23 *to Administrative Claims – Duplicated Claims* (the “**Objection**”) (Docket No. 1694), seeking to
24 disallow certain administrative expense claims identified in **Exhibit 1** thereto (Docket No. 1694-

1) as duplicative pursuant to 11 U.S.C. §§ 502 and 503 and Rule 3007(d), and L.B.R. 3007-1 of the Federal Rules of Bankruptcy Procedure.

NOW, THEREFORE, it appearing to the Court that notice of the *Objection* and the opportunity for any party in interest to respond thereto have been adequate and appropriate as to all parties affected and/or claimants, and that the legal and factual bases set forth in the *Objection* and other documents filed in connection therewith establish just cause for the relief granted herein; and after due deliberation thereon and good cause appearing therefor, the Court makes and issues the following findings of fact and conclusions of law, and orders:

ORDER

NOW, THEREFORE, IT IS ORDERED, ADJUDGED, DECREED, AND DETERMINED THAT:

1. *Debtors' Third Omnibus Objection to Administrative Claims – Duplicated Claims* (Docket No. 1694) is hereby **GRANTED**.

2. The Court finds that the administrative expense claims identified in **Exhibit 1** hereto under the column titled "**Claim No**" are duplicative of the claims identified under the column titled "**Duplicative To**", as such claims arise from the same underlying obligations and seek recovery on the same basis, and that disallowance of such duplicative claims is necessary to prevent double recovery and to preserve the assets of the Debtors' estates.

3. All administrative expense claims identified in **Exhibit 1** hereto under the column titled "**Claim No**" are hereby disallowed in their entirety as duplicative pursuant to 11 U.S.C. §§ 502 and 503 and Rule 3007(d) of the Federal Rules of Bankruptcy Procedure and shall be removed and expunged by the Claims Agent from the claims register.

4. The administrative expense claims identified in **Exhibit 1** hereto under the column titled "**Duplicative To**" shall be deemed allowed and remain on the claims register, unless objected on other grounds by the Debtors.

5. The Debtors are authorized to take all actions necessary to effectuate the relief granted in this Order.
