

**ORDER GRANTING FIRST AND FINAL APPLICATION OF
HMP ADVISORY HOLDINGS, LLC DBA HARNEY PARTNERS AS CHIEF
RESTRUCTURING OFFICER AND FINANCIAL ADVISOR TO THE DEBTORS,
FOR ALLOWANCE OF COMPENSATION FOR SERVICES
RENDERED AND REIMBURSEMENT OF EXPENSES INCURRED**

CAME ON FOR CONSIDERATION the First and Final Application of HMP Advisory Holdings, LLC d/b/a Harney Partners (“HP”) as Chief Restructuring Officer and Financial Advisor to the Debtors, for Allowance of Compensation for Services Rendered and Reimbursement of

Expenses Incurred (the “**Application**”). After considering the Application² and all responses thereto, the Court is of the opinion it should be granted. It is, therefore,

ORDERED that the total amount of \$86,535.00 (the “**Total Amount**”) in fees billed by HP for services provided to the Debtors from February 2, 2026 through May 1, 2026 (the “**Application Period**”), is hereby approved on a final basis; and

IT IS FURTHER ORDERED that Applicant is entitled to receive payment of the Total Amount by drawing down from the Retainer and/or by payment by the Debtors, and that such payment is approved.
