**TWELFTH ORDER MODIFYING THE
AUTOMATIC STAY TO ALLOW CERTAIN
CLAIMANTS TO LIQUIDATE BUT NOT OTHERWISE
COLLECT OR ENFORCE A MEDICAL MALPRACTICE CLAIM
WITH RESPECT TO THE MOTIONS IDENTIFIED ON THE ATTACHED
EXHIBITS A AND B SEEKING MODIFICATION OF THE AUTOMATIC STAY**

On August 18, 2006 and October 12, 2006, the United States Bankruptcy Court for the Southern District of New York (the “Court”) entered orders (the “August 18 Order” and the “October 12 Order,” respectively, and together, the “Initial Lift Stay Orders,” see Docket Nos. 2038 and 2285) (i) modifying the automatic stay imposed by section 362(a) of title 11, United States Code (the “Stay”), with respect to those medical malpractice claimants (the “Medical Malpractice Claimants”) listed on Exhibit “A” to the Initial Lift Stay Orders – which Medical Malpractice Claimants had filed motions for modification of the Stay in order to pursue claims for alleged medical malpractice against Saint Vincents Catholic Medical Centers of New York d/b/a Saint Vincents Catholic Medical Centers, one of the debtors and debtors in possession (collectively, the “Debtors”) in the above-captioned chapter 11 bankruptcy cases (the “Cases”), and (ii) adjourning to subsequent status conferences the motions for modification of the Stay made by the Medical Malpractice Claimants listed on Exhibit “B” to the Initial Lift Stay Orders. The Initial Lift Stay Orders are incorporated herein by reference.

At a status conference held on November 16, 2006 (the “November Status Conference”), the Debtors and the official committee of tort creditors appointed in the Cases (the “Tort Claimants’ Committee”) requested that this Court modify the Stay for all of the motions listed on the revised Exhibits “A” and “B.” The revised exhibits had been updated to reflect recently-filed motions by Medical Malpractice Claimants for modification of the Stay. To the extent necessary, the record of the November Status Conference is incorporated herein by reference.

Subsequently, on November 21, 2006, this Court entered an order modifying the Stay with respect to the Medical Malpractice Claimants that filed the motions listed on Exhibits “A” and “B,” as revised for the November Status Conference (the “November 21 Order,” see Docket No. 2437).

At a status conference on December 14, 2006 (the “December 14 Status Conference”), the Debtors informed this Court of their intent to further revise Exhibits “A” and “B” to include eight (8) additional motions for modification of the Stay. On December 20, 2006, this Court entered an order modifying the Stay with respect to these eight (8) additional motions (the “December 20 Order,” see Docket No. 2550).

At a status conference on January 24, 2007 (the “January 24 Status Conference”), the Debtors submitted further revised Exhibits “A” and “B,” which included twenty-two (22) additional motions for modification of the Stay. On January 24, 2007, this Court entered an order modifying the Stay with respect to these twenty-two (22) additional motions (the “January 24 Order,” see Docket No. 2690).

At a status conference on February 21, 2007 (the “February 21 Status Conference”), the Debtors submitted further revised Exhibits “A” and “B,” which included

twenty (20) additional motions for modification of the Stay. On February 23, 2007, this Court entered an order modifying the Stay with respect to these twenty (20) additional motions (the “February 23 Order,” see Docket No. 2829).

At a status conference on March 22, 2007, (the “March 22 Status Conference”) the Debtors submitted further revised Exhibits “A” and “B,” which included eight (8) additional motions for modification of the Stay. On March 23, 2007, this Court entered an order modifying the Stay with respect to these eight (8) additional motions (the “March 23 Order,” see Docket No. 2969).

At a status conference on April 24, 2007, (the “April 24 Status Conference”) the Debtors submitted further revised Exhibits “A” and “B,” which included nine (9) additional motions for modification of the Stay. On April 25, 2007, this Court entered an order modifying the Stay with respect to these nine (9) additional motions (the “April 25 Order,” see Docket No. 3046).

At a status conference on June 5, 2007, (the “June 5 Status Conference”) the Debtors submitted further revised Exhibits “A” and “B,” which included seven (7) additional motions for modification of the Stay. On June 6, 2007, this Court entered an order modifying the Stay with respect to these seven (7) additional motions (the “June 6 Order,” see Docket No. 3213).

At a status conference on June 20, 2007, (the “June 20 Status Conference”) the Debtors submitted further revised Exhibits “A” and “B,” which included ten (10) additional motions for modification of the Stay. On June 21, 2007, this Court entered an order modifying the Stay with respect to these ten (10) additional motions (the “June 21 Order,” see Docket No. 3286).

At a status conference on July 19, 2007, (the “July 19 Status Conference”) the Debtors submitted further revised Exhibits “A” and “B,” which included four (4) additional motions for modification of the Stay. On July 20, 2007, this Court entered an order modifying the Stay with respect to these four (4) additional motions (the “July 20 Order” and, together with the August 18 Order, the October 12 Order, the November 21 Order, the December 20 Order, the January 24 Order, the February 23 Order, the March 23 Order, the April 25 Order, the June 5 Order and the June 21 Order, the “Lift Stay Orders,” see Docket No. 3406).

Since the July 19 Status Conference, the Debtors have identified nine (9) additional motions or stipulations for modification of the Stay (collectively, the “Twelfth Order Lift Stay Motions,” see Docket Nos. 3378/3398, 3488, 3520, 3533, 3549, 3564, 3566, 3567, and 3579). The Debtors and the Tort Claimants’ Committee have reviewed each of the Twelfth Order Lift Stay Motions to determine whether it should be included on a revised Exhibit “A” or Exhibit “B.” At a status conference held by this Court on August 27, 2007 (the “August 27 Status Conference,” and, together with the November Status Conference, the December 14 Status Conference, the January 24 Status Conference, the February 21 Status Conference, the March 22 Status Conference, the April 24 Status Conference, the June 5 Status Conference, the June 20 Status Conference and the July 19 Status Conference, the “Status Conferences”), the Debtors informed this Court of their intent to revise Exhibits “A” and “B” to include the Twelfth Order Lift Stay Motions. These revised Exhibits “A” and “B” are attached to this Order.

With respect to the Twelfth Order Lift Stay Motions, this Court **FINDS** as follows:

1. This Court has jurisdiction to consider the Twelfth Order Lift Stay Motions and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334 and the Standing

Order of Referral of Cases to Bankruptcy Court Judges of the District Court for the Southern District of New York, entered July 11, 1984 (Ward, Acting C.J.).

2. Consideration of the Twelfth Order Lift Stay Motions and the relief requested therein is a core proceeding pursuant to 28 U.S.C. § 157(b).

3. Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409.

4. Due and proper notice of the Twelfth Order Lift Stay Motions and the August 27 Status Conference has been provided, and no other or further notice need be provided or hearing held before this Court renders its decision with respect to the Twelfth Order Lift Stay Motions.

5. Sections 105(a) and 362 of the Bankruptcy Code provide the statutory predicates for the relief granted herein.

6. For the reasons set forth at the Status Conferences, which are incorporated herein by reference, and having reviewed the Twelfth Order Lift Stay Motions and the relevant responses to the Twelfth Order Lift Stay Motions (where applicable), and having considered the arguments and presentations of counsel for the Debtors, the Medical Malpractice Claimants, and the Tort Claimants' Committee at the August 27 Status Conference (where applicable), due cause exists to modify the Stay consistent with the August 18 Order and the November 21 Order (to the extent applicable) for all motions listed on the attached, revised cumulative Exhibits "A" and "B."

NOW, THEREFORE, IT IS HEREBY **ORDERED** that:

A. By this order (the "Twelfth Lift Stay Order"), the Stay is hereby modified solely to permit those actions that are identified in the Twelfth Order Lift Stay Motions and have

been added to the revised Exhibit “A” or Exhibit “B” hereto, as appropriate, to be liquidated in state court in accordance with the terms and conditions of the August 18 Order.

B. The injunction established by the August 18 Order with respect to the House Staff (as that term is used in the August 18 Order) is hereby modified to permit those actions that are identified in the Twelfth Order Lift Stay Motions and have been added to the revised Exhibit “A” or Exhibit “B” hereto, as appropriate, solely to allow claims against the House Staff related to such actions to be liquidated in state court in accordance with the terms and conditions of the August 18 Order. The Debtors may defend or provide for the defense of the member or members of the House Staff implicated in any such action, consistent with the Debtors’ past practice and ordinary course of business with respect to medical malpractice claims.

C. All other terms, conditions and procedures set forth in the Lift Stay Orders shall continue in full force and effect.
