Perella Weinberg Partners ("PWP"), as Investment Banker to the above captioned Debtors

(the "Debtors" or the "Reorganized Debtors"), hereby submits this Amended Second Interim and

*the Period From November 13, 2020 Through and Including April 28, 2021* (this "<u>Application</u>") for (a) interim allowance of compensation for professional services provided in the amount of \$7,771,917.81, and reimbursement of actual and necessary expenses in the amount of \$4,200.60 for the period February 1, 2021 through April 28, 2021 ("<u>Second Interim Period</u>") and (b) final allowance of compensation for professional service provided in the amount of \$8,161,917.81, and reimbursement of actual and necessary expenses in the amount of \$8,161,917.81, and reimbursement of actual and necessary expenses in the amount of \$8,161,917.81, and reimbursement of actual and necessary expenses in the amount of \$21,384.67 that PWP incurred for the period from November 13, 2020 to April 28, 2021 (the "<u>Final Period</u>"). In support of this Application, PWP respectfully states as follows:

#### Jurisdiction and Venue

1. The United States Bankruptcy Court for the Southern District of Texas (the "<u>Court</u>") has jurisdiction over this matter pursuant to 28 U.S.C. § 1334. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b). The Debtors confirm their consent to the entry of a final order by the Court.

2. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409.

3. The bases for the relief requested herein are sections 327, 328, 330, and 331 of title 11 of the United States Code (the "<u>Bankruptcy Code</u>"), rule 2016 of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>"), and rule 2016-1 of the Bankruptcy Local Rules for the Southern District of Texas (the "Bankruptcy Local Rules").

#### **Background**

4. On November 13, 2020 (the "<u>Petition Date</u>"), each of the Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code. No request for the appointment of a trustee or examiner has been made in these chapter 11 cases.

5. On December 11, 2020, the Court entered the Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Professionals [Docket No. 387]

(the "<u>Fee Procedures Order</u>"), which sets forth the procedures for interim compensation and reimbursement of expenses for all professionals in these cases.

6. The following exhibits are attached in support of this Application, and are fully incorporated herein for all purposes:

#### **Retention of PWP and Billing History**

7. On December 11, 2020, the Debtors submitted to the Court the Debtors' Application For Entry of An Order Authorizing the Retention and Employment of Perella Weinberg Partners LP as Financial Advisor and Investment Banker for the Debtors and Debtors in Possession Effective as of the Petition Date [Docket No. 384] (the "Retention Application"). On March 2, 2021, the Court entered the Order Authorizing the Retention and Employment of Perella Weinberg Partners LP as Financial Advisor and Investment Banker for the Debtors and Employment of Perella Weinberg Partners LP as Financial Advisor and Investment Banker for the Debtors and Employment of Perella Weinberg Partners LP as Financial Advisor and Investment Banker for the Debtors and Debtors and Debtors in Possession Effective as of the Petition Date [Docket No. 855].

8. Pursuant to the Fee Procedures Order, on March 19, 2021, PWP filed the *First Interim Fee Application of Perella Weinberg Partners LP, Investment Banker to the Debtors and Debtors in Possession for the Period from November 13, 2020 to January 13, 2021* (the "<u>First</u> <u>Interim Application</u>") [Docket No. 951]. The Court has not yet entered the order approving the First Interim Application, which remains pending.

9. A summary of the total hours expended during the Second Interim Period per professional, is attached hereto as **Exhibit A**.

#### **Summary of Professional Services Rendered**

10. In conjunction with its engagement as Investment Banker for the Debtors, PWP established the following categories relating to the various subject matter categories of work performed (the "<u>Categories</u>") by PWP's professionals in conjunction with these chapter 11 cases:

11. During the Second Interim Period, and in conjunction with the various and complex issues involved in the administration of the chapter 11 cases, PWP expended time and rendered services to the Debtors for each of the Categories that were both necessary and beneficial to the Debtors and their estates, creditors, and other parties in interest. PWP's professionals performed work and billed time for each of the Categories as set forth below and as shown in the attached **Exhibit B**. In further support of the Application, a more detailed and itemized description of the services provided by PWP for each of the Categories is set forth in **Exhibit C**.

# A. Correspondence with Debtors and Counsel

12. PWP's services performed relating to this Category included, among other things, communications with the Debtors and counsel regarding case strategy, the scheduling of internal updates and discussions, and other internal coordination with the Debtors' advisors.

#### **B.** Analysis, Presentation, and Due Diligence

13. PWP's services performed relating to this Category included, among other things, general research, analysis, due diligence, and preparation of analysis related to the Debtors' disclosure statement and valuation.

#### **C.** General Case Administration

14. PWP's services performed relating to this Category included, among other things, compilation of time records, preparation and reconciliation of invoices, and the preparation and submission of monthly and interim fee Applications.

#### D. Correspondence with Creditors / UCC / Special Committee

15. PWP's services performed relating to this Category included, among other things, correspondence with the creditors, the UCC, the Special Committees, and their respective advisors.

#### **E.** Court Hearings

16. PWP's services performed relating to this Category included, among other things, participation in court hearings.

#### **F. Board Meetings**

17. PWP's services performed relating to this Category included, among other things, review, preparation for, and participation in the Debtors' board meetings.

#### **Basis for Allowance of Compensation and Expenses**

18. Section 330 of the Bankruptcy Code provides that a court may award to a professional person, reasonable compensation for actual, necessary services. *See* 11 U.S.C. \$ 330(a)(1)(A). In determining the amount of reasonable compensation to award, the court must take into account all relevant factors, including: (a) the time spent; (b) rates charged; (c) whether the services were necessary or beneficial in the bankruptcy case; (d) whether the time expended was commensurate with the complexity, importance, and nature of the issues or tasks; (e) whether the professional is board certified or has otherwise demonstrated skill and experience in the bankruptcy field; and (f) whether the compensation is reasonable based on customary charges of comparable practitioners in other bankruptcy cases. 11 U.S.C. \$ 330(a)(3)(A).

19. Among the *Johnson* factors that courts may consider in adjusting compensation for professionals are: (i) time and labor required for the task; (ii) the novelty and difficulty of the issues involved; (iii) the skill required to properly perform the services; (iv) any resulting preclusion from other employment; (v) customary fees; (vi) whether the professional's fee is fixed or contingent; (vii) time limitations imposed by the client or other circumstances; (viii) the results achieved; (ix) the nature and length of the professional relationship with the client; and (xi) awards in similar cases. *See Johnson v. Georgia Highway Express, Inc.*, 488 F.2d 714, 717-19 (5th Cir. 1974); *see also Cooper Liquor, Inc. v. Adolph Coors Co.*, 684 F.2d 1087 (5th Cir. 1987).

20. In light of the above factors listed in section 330 of the Bankruptcy Code and the *Johnson* factors, PWP submits that the fees and expenses incurred for the Second Interim Period were reasonable, necessary, and should be allowed in their entirety.

# A. PWP's Time and Labor Expended was Reasonable, Necessary, and Commensurate with the Tasks and Issues Involved and the Complexity of the Bankruptcy Cases.

21. *Time and labor required.* PWP billed a total of 1,036.5 hours through April 28, 2021 in conjunction with their engagement as the Debtors' Investment Banker. A summary of the hours worked during the Second Interim Period for each Category is attached hereto as **Exhibit B**, and a summary of the tasks performed in conjunction with each Category is set forth above. A more detailed itemization of the daily tasks performed is submitted as **Exhibit C** to this Application.

22. *Novelty and difficulty of the questions addressed*. PWP additionally submits that the time it spent in conjunction with the matters and issues addressed in each Category was commensurate with the importance, novelty, and difficulty of the issues and questions addressed. The size of the Debtors' businesses and the large number of creditors and parties in interest in the chapter 11 cases contributed to the complexity of the financial matters involved and the time and efforts required from PWP professionals.

23. *Skill requisite to perform services properly*. Due to the size and complexity of the chapter 11 cases, the services performed by PWP professionals on behalf of the Debtors during the Second Interim Period have required the services of skilled professionals with expertise and specialized background in complex chapter 11 bankruptcy cases.

# **B. PWP's Rates are Reasonable and Comparable to Rates of Investment Bankers** with Similar Skill and Reputation.

24. *Fees customarily charged*. As disclosed more fully in PWP's retention Application, PWP does not customarily charge for its services on an hourly basis nor does it ordinarily track the amount of time spent by employees on a particular task. However, as a

condition of its retention, PWP has agreed to record time spent on this engagement. A summary of the number of hours expended per professional is attached hereto as **Exhibit C**.

#### C. **PWP's Professionals are Experienced and Well Qualified.**

25. *Experience, reputation, and ability.* PWP's professionals are well qualified for the work performed on behalf of the Debtors and specialize in the areas of general liability management and restructuring, capital markets knowledge, merger and acquisition capabilities, and other matters related to complex chapter 11 reorganizations. Accordingly, PWP has performed the services requested by the Debtors skillfully and efficiently, to the collective benefit of the Debtors, creditors, and all parties in interest in these chapter 11 cases. In conjunction with its engagement in the chapter 11 cases, and as indicated on **Exhibit A**, PWP has utilized the services of various professionals with a range of experience to employ the proper level of experience for the specific work performed.

## **D.** Nature of Case and PWP's Relationship with the Debtors.

26. *Nature and length of the professional relationship with the Debtors.* PWP was engaged by the Debtors prior to the Petition Date to provide financial advisory services on various matters, including the evaluation of merger and acquisition opportunities, analysis of various liability management scenarios, and negotiation of key economic terms on the RSA. Accordingly, PWP has utilized its familiarity with the Debtors' businesses to further provide services in a most efficient and effective fashion.

27. *Awards in similar cases*. PWP believes that the amount requested pursuant to this Application is consistent with fees charged by similarly skilled professionals for comparable services in other complex chapter 11 bankruptcy cases. In addition, as set forth above, PWP submits that PWP's fee is within the range of rates customarily charged by other firms with comparable expertise, skills, and reputation.

WHEREFORE, PWP respectfully requests that the Court enter an order (a) interim allowance and payment of compensation for professional services provided in the amount of \$7,771,917.81 and reimbursement of actual, reasonable and necessary expenses in the amount of \$4,200.60 for the period February 1, 2021 through April 28, 2021, (b) final allowance and payment of compensation for professional services provided in the amount of \$8,161,917.81, and reimbursement of actual and necessary expenses in the amount of \$8,161,917.81, and reimbursement of actual and necessary expenses in the amount of \$21,384.67 that PWP incurred for the period November 13, 2020 through April 28, 2021, (c) authorizing and directing the Debtors to remit payment to PWP for such fees and expenses not previously paid, and (d) granting such other relief as is appropriate under the circumstances.
